 maintaining the records under the applicable Labour Laws in the respect of all the worker(s)
 deployed/shall be deployed in the premises of the Principal Employer.
- That the process(es)/work/job(s) on which the contact workers are to be deployed/shall/engaged is/are not abolished by any Authority or Board under the provisions of Contract Labour (R & A) Act, 1970.
